2. BACKGROUND

The Special Procurement Notice (SPN) was advertised in The Daily News, The Financial Gazette, Government Gazette, Sunday News, The Sunday Mail, Online at dgMarket Worldwide Tenders and the IDBZ website (URL <https://www.idbz.co.zw/project-operations/procurement-notice/expressions-interest/invitation-bids-ifb-prequalification>) from 8 to 11 August 2024. The original closing deadline for submission of applications was 23 August 2024 at 10:00am CAT. Following a non-compulsory pre-bid meeting held on 16 of August 2024, the deadline was extended to 27 August 2024 at 10:00am CAT.

3. OPENING OF BIDS

Thirty-six (36) bidders submitted their bids by the submission deadline of 27 August 2024 at 10:00am CAT. Opening of the bids started at 10:00am CAT. The submissions were read out aloud by the Head of the Procurement Management Unit.
